The *Northwestern Mindanao State College of Science & Technology (NMSCST)*, through the *Special Trust Fund FY 2022* intends to apply the sum of Two Million Seven Hundred Forty Thousand Five Hundred Thirty Pesos Only (Php. 2,740,530.00) being the ABC to payments under the contract for Delivery and Installation of Dedicated Connection via Fiber Optic Cable/22PBTNMSC01-G. - 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 5.
