



## INVITATION TO BID FOR

### *Delivery and Installation of Dedicated Connection via Fiber Optic Cable*

1. The *Northwestern Mindanao State College of Science & Technology (NMSCST)*, through the *Special Trust Fund FY 2022* intends to apply the sum of Two Million Seven Hundred Forty Thousand Five Hundred Thirty Pesos Only (Php. 2,740,530.00) being the ABC to payments under the contract for Delivery and Installation of Dedicated Connection via Fiber Optic Cable/22PBTNMSC01-G. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NMSCST now invites bids for the above Procurement Project. Delivery and Installation of the Goods is required by 30 Calendar Days and 2-years 200mbps of internet subscription. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *Northwestern Mindanao State College of Science and Technology* and inspect the Bidding Documents at the address given below during 8:00 AM – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on January 10, 2022 – *January 31, 2022* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Seven Hundred Forty Pesos Only (Php. 2,740.00).*
6. The NMSCST will hold a Pre-Bid Conference<sup>1</sup> on *January 18, 2022 at 01:00 PM through video conferencing or webcasting via google meet (please see meeting ID details below)* which shall be open to prospective bidders.
