

## **INVITATION TO BID FOR** Procurement of Learning Materials

- 1. The Northwestern Mindanao State College of Science & Technology (NMSCST), through the STF FY 2022 intends to apply the sum of Two Million Nine Hundred Ninety-Two Thousand Pesos Only (Php. 2,992,000.00) being the ABC to payments under the contract for Procurement of Supplies for Learning Materials/22BPTNMSC02-G. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 1. The *NMSCST* now invites bids for the above Procurement Project. Delivery of the Goods is required by *month of July, August and September of 2022*. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 2. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 3. Prospective Bidders may obtain further information from *NMSCST* and inspect the Bidding Documents at the address given below during 8:00 5:00 PM.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders on June 2 22, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount listed below for the lot/item. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through Palawan/Cebuana.

- 5. The NMSCST will hold a Pre-Bid Conference<sup>1</sup> on *June 10, 2022 at 01:00 PM through* video conferencing or webcasting *via Google Meet (please see meeting ID details below)* which shall be open to prospective bidders.
- 6. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below. Late bids shall not be accepted.
