THIS CONTRACT is made this 26th day of June, 2019 between **NORTHWESTERN MINDANAO STATE COLLEGE OF SCIENCE AND TECHNOLOGY (NMSCST)**, with office address at Labuyo, Tangub City, Misamis Occidental, represented herein by **Dr. WILSON C. NABUA**, the OIC President/HOPE (hereinafter called the "ENTITY") and **PLDT INC.**, with office address at Ramon Cojuangco Building, Makati Avenue, Makati City, represented by **ALBERT MITCHELL L. LOCSIN**, the First Vice President and Head - PLDT SME Nation (hereinafter called the "SUPPLIER").

WHEREAS, the Entity invited Bids for the execution of the Works under Contract I.D. 




