



INVITATION TO BID FOR
MSMEs Improved Services and Operations for Competitiveness of Communities
thru Food Innovation Convergence (MISOCC – FIC)

1. The *Northwestern Mindanao State College of Science & Technology (NMSCST)*, through the *STF FY 2021* intends to apply the sum of One Million Nine Hundred Thousand Pesos Only (Php. 1,900,000.00) being the ABC to payments under the contract for MSMEs Improved Services and Operations for Competitiveness of Communities thru Food Innovation Convergence (MISOCC – FIC)/20BPTNMSC08-G. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *NMSCST* now invites bids for the above Procurement Project. Delivery of the Goods is required by *60 Calendar Days*. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *NMSCST* and inspect the Bidding Documents at the address given below during 8:00 – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *June 9 – 29, 2021* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Nine Hundred Pesos Only (Php. 1,900.00)*.
6. The *NMSCST* will hold a Pre-Bid Conference¹ on *June 17, 2021 at 01:00 PM* through video conferencing or webcasting *via zoom (please see meeting ID details below)* which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below. Late bids shall not be accepted.
