

INVITATION TO BID FOR

Acquisition of Ancillary State-of-the Art Laboratory Facilities for Electrical and Electronics Engineering Technology Leading to Industry 4.0

- 1. The Northwestern Mindanao State College of Science & Technology (NMSCST), through the STF FY 2022 intends to apply the sum of Four Million Nine Hundred Ninety-Nine Thousand Eight Hundred Pesos Only (Php. 4,999,800.00) being the ABC to payments under the contract for Acquisition of Ancillary State-of-the Art Laboratory Facilities for Electrical and Electronics Engineering Technology Leading to Industry 4.0/22PBTNMSC03-G. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *NMSCST* now invites bids for the above Procurement Project. Delivery of the Goods is required by 60 Calendar Days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from NMSCST and inspect the Bidding Documents at the address given below during 8:00-5:00 PM, Monday-Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on February 07 March 01, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount listed below for the lot/item. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through Palawan/Cebuana.
